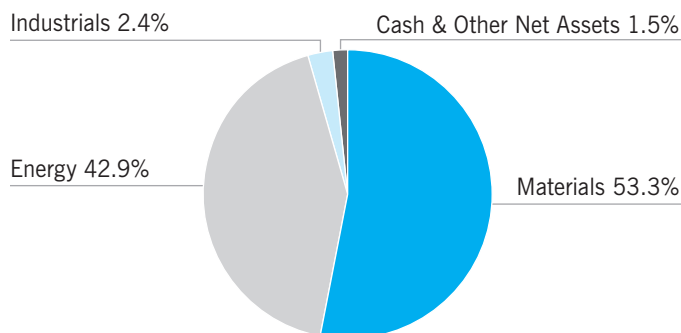

### INVESTOR PROFILE

Suited to investors seeking growth provided by capital appreciation of Canadian equities focused on the energy and materials sectors and with a long-term investment horizon. Investors should be able to accept a moderate to high level of risk.

### INVESTMENT OBJECTIVE

To achieve long-term capital appreciation by investing primarily in equity securities of Canadian resource companies listed on the Toronto Stock Exchange.

### INVESTMENT STRATEGY

The fund intends to achieve its objective by investing primarily in equity securities of businesses involved in the exploration and production of natural resources, such as metals, non-metallic minerals, forest products, oil and gas. There may be a shift in emphasis from one natural resource to another depending on market conditions, and when appropriate, the fund may invest in debt instruments.

To assist with objectives, futures contracts, forward contracts, swaps, options, and other derivatives may be used for hedging purposes. The fund may also use derivatives for non-hedging purposes provided they are not used for speculative purposes.

ESG criteria is also incorporated in the investment analysis and decision-making process.
